- Please notify all judges and all volunteers from your team so that they may prepare. Note that NOQ means assigned to that role during the National Open Qualifier in morning on Wed. June 20th.
- Special Notes:**
- Please make sure you notify alternates as well. Alternates should check-in each day and prior to each judging group to see if they will be needed.
 - These assignments are subject to change. An updated final list will be sent to coaches in early-June.
- Alternate Speed/4th Clicker Judges should be prepared to judge and will be stationed near the competition floor during all speed events. Alternate/4th Clicker judges will be used.
 - All Judges and Volunteers are expected to be available **each day** during the tournaments.
 - The deadline passed for providing changes in the availability of your team's judges and volunteers. If there are any late changes, please send email ASAP to nationals@usajumprope.org
 - We would like to recognize judges that will be serving their 5th, 10th, 15th, or 20th year as a Nationals judge this year. Please send us an email with their names and anniversary year **by Fri. June 8th**.

Coaches and Judges will be **required** to download their copy of the 2018 USAJR Nationals Coaches/Judge Manual prior to arriving at Nationals. This manual will be sent by email to all coaches to forward to their team's judges, and it will also be available on the USAJR website under forms.

Required Judge Meetings and Testing:

- Mandatory Meeting for all Coaches, Judges, and Volunteers **Tues. June 19th 5:00-6:00pm** at the Chula Vista Resort. Floor Clerk Volunteers will meet with Brad at 5:30pm.
 - There will be brief breakout sessions for Presentation and Content Judges immediately following the Coaches & Judges Meeting.
 - All Freestyle Head Judges and Alternate Freestyle Head Judges will be required to take an online test prior to Nationals. These judges will be emailed the test information and deadline date.
 - All Speed Judges and 4th Clicker/Alternate Speed Judges will be required to attend an additional Speed Judge meeting prior to the start of competition and immediately following the Parade of Athletes on Wed. June 20th.
 - All Team Show Judges and Alternate Team Show Judges will be required to attend a brief breakout session following the awards ceremony on Thursday.
- **All Judges, Floor Managers, Tabulators, Runners, Floor Clerks, and Volunteers must wear the following when working:**
 1. **A white USAJR polo shirt or a plain white shirt.** Last year, there were several judges that had on shirts with other logos. ONLY USAJR logos please!!
 2. Navy pants, capris, shorts or skirt. (No denim please!)
 3. Wear athletic shoes (no sandals or flip-flops)
 4. It can be a bit cool in the air-conditioning. If you would like to wear a sweater or sweatshirt, it should be plain white, white with a USAJR logo, plain navy, or navy with USAJR logo.
